- (iii) As per the information received by us the college has a canteen running & ATM Machine Within its premises for which neither any contract has been entered into, nor there are any entries found in the books of account relating the receipts and Payments of canteen.
- (iv) The College has showing Freehold Land of Rs 661/- and Leasehold Land of Rs 635/- are not verified by us since supporting papers are not available.
- (v) The CPF of employee's are not deposited at the time of payment of salary which is paid in advance before the receipt of grant relating to salary is not deposited within time even after the receipt of grant.
- (vi) Interest from FDR are taken as per accrual Basis.
- (vii) During our Audit we came to know that the college is not maintaining Any Register for the grants received and utilizations made thereof.
- (viii) We have observed that Punjab National Bank with A/c No.0100223700 & Durg Treasury P.D.Account maintained by college management is not reconciled from past few years due to which financial errors/ fraud can be occur in upcoming financial years. So we suggest that management should take initiative to reconcile the above mentioned bank details.
  - (ix) As per our suggestion manual receipts for fees taken should not be allowed as it may cause error /fraud in futures. Receipts should be generated through proper software used for fees collection.
    - (x) Fees collected from student and deposited the same on Regular basis however fees collection summery collection deposit was not cross verified by the management.
      - (xi) Fees Reconciliation for all student wise & class wise and course wise not prepared by the college.
